The Substance Use Disorder Certified Peer Counselor reports to the appropriate Therapeutic Court Program Manager. SUBSTANCE USE DISORDER CERTIFIED PEER COUNSELOR

GENERAL DESCRIPTION

The Substance Use Disorder Certified Peer Counselor (CPC) is responsible for providing peer support, advocacy, and linkage services to individuals with substance use disorders, with emphasis on clients who are at risk of opioid overdose/poisoning, those who are homeless, and those involved in Therapeutic Courts. The Substance Use Disorder Certified Peer Counselor reports to the appropriate Therapeutic Court Program Manager. This is a part-time, non-exempt position.

MAJOR RESPONSIBILITIES – Specific to this position

• Provide outreach and engagement services to individuals in need of support and use a warm handoff approach to connect to appropriate care



- Provide peer-to-peer support services including but not limited to, support, encouragement, guidance, and advocacy for clients and their families
- Utilize their lived experience to build rapport and trust while helping individuals fully engage in services and assist them in addressing and overcoming barriers to treatment
- Participate as a member of a multidisciplinary team, addressing concerns, barriers, progress, and other relevant information to enhance treatment services; assisting and supporting clients in maintaining cooperative and effective relationships with these teams
- Actively promote and facilitate connection with other CHS programs for families and individuals such as childcare, parenting classes, play & learn groups, Promoting First Relationships program, Infant and Early Childhood Mental Health, etc.
- Assist with the orientation process for new Adult Recovery Court participants
- Facilitate Peer Recovery Groups as assigned
- Advocate for clients while supporting compliance
- Link clients to resources, services, and supports. Addressing barriers to treatment such as housing, employment, education, medical or mental health needs
- Provide individualized guidance and support to address the stigma, discrimination, and exploitation that individuals face as a result of their substance use disorder and possible related behaviors when in early recovery
- Provide training and consultation to probation officers, community groups, healthcare providers, and others, regarding
 issues facing clients
- Maintain accurate and thorough clinical records as per agency, county, and state requirements
- Provide input and report to the Therapeutic Court Manager, Associate Director, and Director regarding the clinical needs of clients, and improved ways of offering prevention, outreach, treatment services, and supervision.
- Attend group and individual sessions as requested and maintain supportive interaction with clients, clinicians, and other social supports
- Commit to required trainings, including audio and video recordings required for evidence-based practices if required
- Conduct collaboration documentation with clients during peer-to-peer sessions
- Complete Credible notes for billing immediately following services
- Participate in individual supervision, staff meeting, Case Consultations, and all-staff meetings as scheduled
- Maintain a professional, courteous, and respectful attitude to all clients, partners and community members
- Maintain status as a qualified Certified Peer Counselor

MAJOR RESPONSIBILITIES – Agency in general Provide all services utilizing a strengths-based, family-focused, client-centered, trauma-informed, culturally humble approach that is integrated with other services

- Participate in creating and maintaining a safe workplace that values diversity and treats everyone with dignity and respect without regard to race, color, age, religion, creed, gender, gender identity, gender expression, sexual orientation, national origin, marital status, the presence of any sensory, mental, or physical disability
- Utilize teamwork and open communication
- Provide services in a manner that expedites the meeting of contract requirements and program outcomes
- Maintain documentation in a timely, thorough, and accurate manner
- Follow agency policies and procedures, RCWs, WACs, CARF standards, and other external regulations
- Follow CHS's Code of Ethics
- Perform all other tasks as assigned by the supervisor, managers, or directors that further the success of programs and/or the agency

- Direct lived experience as someone with a substance use disorder in recovery, with additional preference to those with previous experience navigating systems such as Therapeutic/Recovery/Drug Courts, behavioral health services, the incarceration system, state-level departments such as DSHS, and/or other systems related to accessing services.
- Extensive knowledge of community area resources and how to access those resources
- Available to work some evening hours on a regular schedule
- No misuse of alcohol or other drugs within the previous 2 years
