#### **GENERAL DESCRIPTION**

The WISe (Wraparound with Intensive Services) Child and Family Therapist is responsible for providing mental health counseling as part of a multi-disciplinary treatment team. Teams will work with youth and families who have complex needs and who are often involved in multiple systems (juvenile justice, child welfare, special education, substance abuse, etc). The Therapist will work with youth and families in their home, school, and communities. This is a full-time, non-exempt position who reports to the CBIS Program Manager. Salary range is \$70,116.80 - \$82,305.60 depending on credentials and licensure.

- Provide mental health counseling to children, youth, and families based on assessed clinical needs and client identified goals
- Effectively engage youth and families in the treatment process, utilizing evidence-based interventions and/or other researched interventions to provide treatment specific to the youth's behavioral health diagnosis
- Provide all services utilizing a strengths-based, family-focused, culturally humble, and integrated approach
- Create safety and crisis plans with the youth and family and update plans as needed
- Complete mental health intake/diagnostic assessments (MHP only)
- Develop individualized treatment plans for each youth; reviews & updates plans as needed
- Respond to and address clinical crisis situations, including youth who are a risk to themselves or others
- Provide crisis assessment and response (MHP level only)
- Maintain a case load of 12 children/youth ages 6 to 21
- Use the National Wraparound Initiative's "Ten Principles of Wraparound" and the "Phases and Activities of the Wraparound Process" to guide service delivery
- Provide services in accordance to the Wraparound with Intensive Services (WISe) Manual
- Serve as a role model and advocate for youth and families involved in the wraparound process
- Participate in requisite training activities
- Utilize teamwork and open communication
- Participate in weekly supervision, weekly staff meetings, and clinical consultation/affinity group meetings
- Work closely and collaboratively with the WISe Care Coordinators(s), WISe Peer Partner(s), and system partners
- Maintain documentation in a timely, thorough, and accurate manner

### **MAJOR RESPONSIBILITIES – Agency in general**

- Provide all services utilizing a strengths-based, family-focused, client-centered, trauma-informed, culturally humble approach that is integrated with other services
- Participate in creating and maintaining a safe workplace that values diversity and treats everyone with dignity and respect without regard to race, color, age, religion, creed, gender, gender identity, gender expression, sexual orientation, national origin, marital status, the presence of any sensory, mental, or physical disability
- Utilize teamwork and open communication
- Provide services in a manner that expedites the meeting of contract requirements and program outcomes
- Maintain documentation in a timely, thorough, and accurate manner
